We promoted it based on the action plan in each consolidated division. (see page 26)		
We have newly introduced the assessment to iron pipes and air conditioning-related products, and started the operation of it.		
We have abolished using lead completely in part of the paints for construction machinery.		
We have achieved the top level energy conservation in four types of our automatic vending machines in the industry. (see page 19)		
Ne have investigated the environmental activities of the suppliers of our two consolidated divisions. Ne have conducted environmental load reducing activities in cooperation with the suppliers.
