Notice regarding the resolution on establishing a program of purchasing own shares
(Pursuant to Article 165, Paragraph 2 of the Corporate Law of Japan)

Kubota Corporation (“the Company”) has resolved at the Meeting of the Board of Directors held on May 10, 2016 to establish a program of purchasing own shares, pursuant to Article 156 of the Corporate Law of Japan after applying the regulations of Article 165, Paragraph 3 of said law.

1. Purpose for purchasing own shares

The Company will purchase own shares in order to create more value per share, as a part of returning profit to shareholders.
