**Notice of Interim Dividend**

Kubota Corporation (hereinafter “the Company”) has resolved at the Meeting of Board of Directors held on August 4, 2026, that the Company would pay interim dividend with the record date of June 30, 2026.

**2. Reasons for determination of interim dividend amount**

The Company’s basic policy for the return of profit to shareholders is to maintain stable dividends and raise dividends together with share buybacks and retirement of treasury shares.

Considering the basic policy and the Company’s current business performance, the Company decided to pay ¥26 per common share as the interim dividend of this fiscal year. The forecast for the year-end dividend for this fiscal year is as follows.
