#### 2. Reasons for determination of interim dividend amount

The Company's basic policy for the return of profit to shareholders is to maintain stable dividends and raise dividends together with share buy-backs and retirement of treasury shares.

Considering the basic policy and the Company's current business performance, the Company decided to pay ¥21 per common share as the interim dividend of this fiscal year, which will be ¥4 increase from the previous year ended December 31, 2020.

The specific amount of year-end cash dividend for the year ending December 31, 2021 is not decided at this time.
