Considering the basic policy and the Company's current business performance, the Company intends to propose ¥19 of the year-end dividend per common share.

Accordingly, including the interim dividend of ¥17 per common share already paid, the annual dividend per common share for the fiscal year ending December 31, 2019 will be ¥36, which will be ¥2 increase from the previous fiscal year ended December 31, 2018.
